



REQUEST FOR EXPRESSION OF INTEREST (EOI) FOR LIVELIHOOD RESTORATION COORDINATION FOR THE EACOP PROJECT IN UGANDA REFERENCE: 10006992

TOTAL East Africa Midstream B.V. (Company) Uganda, an Oil and Gas company, requires the services of an experienced and reputable Contractor to coordinate the delivery of Livelihood Restoration support to Project Affected Persons (PAPs) as part of implementation of land acquisition and the Resettlement Action Plan (RAP) for the East African Crude Oil Pipeline (EACOP) Project.

The EACOP Project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region, in Tanzania. The length of the pipeline is 1,443 kilometers (km) of which 296 km will be in Uganda.

In Uganda the pipeline will traverse ten (10) Districts, comprising Hoima, Kikuube, Kakumiro, Kyankwanzi, Mubende, Gomba, Sembabule, Iwengo, Rakai and Kyotera.

BRIEF DESCRIPTION OF THE SCOPE OF WORK

EACOP has prepared a Resettlement Action Plan (RAP), which sets out the compensation and entitlements for PAPs, including livelihood restoration support to be provided to approximately 3,800 affected households. Ten District specific Livelihood Restoration Plans (DIRPs) have been prepared in consultation with stakeholders and describe the livelihood restoration programs available to PAPs.

Livelihood restoration will include programs to promote food security, agricultural improvement programs, as well as enterprise development and vocational skills training.

EACOP will contract livelihood restoration delivery providers to deliver the livelihood packages. For example, livestock improvement support will be delivered by specialist livestock support provider(s).

The COMPANY requires the services of a Contractor to manage, oversee and coordinate the delivery of livelihood

restoration packages by the various delivery providers. They will be required to ensure effective and timely delivery in line with Project standards, timescales and budgets. This EOI notice is for the Livelihood Restoration Coordinator and the contract is anticipated to run for 2 to 3 years until livelihoods are restored.

The Livelihood Restoration Coordinator will need to be experienced in: livelihood restoration support in Uganda, managing and planning the delivery of agricultural improvement programs, enterprise development and vocational training support, as well as project management (planning, program budgeting, financial and contractor management, performance monitoring and reporting).

The scope will require the Contractor to engage with affected households, as well as local stakeholders, livelihood restoration delivery providers, the EACOP Project team and other contractors working on behalf of EACOP on RAP implementation.

MINIMUM REQUIREMENTS

Companies or organisations expressing their interest are required to document their:

- Experience/performance in project managing programs as outlined above on a large scale in Uganda, in compliance with national and international standards.
- Understanding livelihood support delivery at the household level as well as for vulnerable persons.
- Sufficient capacity and resource to deliver the required services, simultaneously along the pipeline route.
- Financial capacity to deliver the required services.
- Proof of current registration to the National Supplier Database for the year 2020-2021.
- Evidence of organisation QHSE policies, procedures and processes in compliance with applicable National and industry standards for similar works.
- If they are an NGO, proof of registration with the National NGO Board and the necessary NGO permit documentation.
- Proof of registration with the Uganda Revenue Authority and Tax Clearance Certificate for the latest year.
